

### Berlin Brandenburg Airport Willy Brandt starts operations

The new Terminal 1 at Berlin Brandenburg Airport Willy Brandt (BER) was opened on 31 October 2020 with the landing of the two aircrafts operated by easyJet and Lufthansa. Upon arrival, the passengers, including easyJet CEO Johan Lundgren and Lufthansa CEO Carsten Spohr, were welcomed in Terminal 1 by the head of the airport company, Engelbert Lütke Daldrup.

The symbolic opening act took place in a small circle and was attended by the Minister President of the State of Brandenburg, Dietmar Woidke, the Govering Mayor of Berlin, Michael Müller,

the Federal Minister of Transport and Digital Infrastructure, Andreas Scheuer MdB, and the Chairman of the Supervisory Board of the airport company, Rainer Bretschneider.

On Sunday, 1 November 2020, regular operations began at Terminal 1 of Berlin Brandenburg Airport Willy Brandt (BER) with the first commercial departures. At 6.45 in the morning, an easyJet aircraft took off for London Gatwick. In the course of the day, a total of 23 departures with over 3,000 passengers took place from the new Terminal 1.

Following the opening of BER, the Airport Region Berlin Brandenburg is experiencing a growth spurt that will have an impact on the entire German capital region. " "We are already registering concrete settlement projects that can be attributed to the international airport. This knock-on effect will only increase, because the Airport Region Berlin Brandenburg is highly attractive for investors," says Dr. Stefan Franzke (Berlin Partner).

The most prominent example is Tesla. The e-mobility pioneer's planned Gigafactory in Grünheide is not only located near the airport, it was also directly connected to the new airport by the company's CEO Elon Musk at the announcement of the location's opening. For a globally operating company like Tesla, an international airport at business locations alone are in the immediate vicinity of its doorstep with direct connections to other continents is a major location advantage.

## THREE QUESTIONS FOR

# Prof. Dr. Engelbert Lütke Daldrup, Chief Executive Officer of FBB GmbH



Airport Region Team: The new Berlin Brandenburg Airport Willy Brandt is now open. What is your first conclusion?

**Engelbert Lütke Daldrup:** The days and weeks before the opening were a huge effort, but the efforts have paid off. The capital region now has an internationally competitive airport. That is a real asset.

Airport Region Team: What impact will it have?

Engelbert Lütke Daldrup: The number of passengers will increase once the pandemic is over. Certainly, this won't happen guickly. Probably, we will not reach pre-COVID

levels again until 2024. But the airport's good transport connections and modern infrastructure will ensure increased interest in BER, both for travelers and the air freight business. This means that the new airport will have an impact on the growth of the entire capital region.

Airport Region Team: We have already seen the signs of this development in the growing interest of investors. What do you expect for the airport region?

Engelbert Lütke Daldrup: To put it in a nutshell, as an economic engine, the BER will boost the economy for the entire region all the way down to Lusatia [in the state of Saxony], even if that will take some time due to the pandemic. We are already cooperating very closely with the business development agencies of Brandenburg and Berlin in developing the environment.

This collaboration between the airport operator and the economic development agencies of Berlin and Brandenburg per se creates an added value for the entire region. We are pleased that the business development agencies also consider Berlin Brandenburg Airport Willy Brandt as a major plus for the region.

## TRAFFIC INFRASTRUCTURE OUTLOOK

### Excellent connections

The BER is well connected to public transport and has its own six-platform railway station with three platforms located directly below Terminal 1. In addition, the BER can be reached by bus, taxi and private car.



#### **Train station**

During rush hour, a total of 14 trains run per hour, including the S-Bahn (every ten minutes) and the IC Dresden-Rostock (about once an hour).

The station is called "Flughafen BER - Terminal 1-2".

The former Berlin-Schönefeld Flughafen station is now called "Flughafen BER - Terminal 5".

Trains run every 10 minutes between both stations, whilst buses run every five minutes.

#### **Services from 2020 onwards**

- FEX: Hauptbahnhof Ostkreuz BER T1 (every 30 minutes)
- RE7: Dessau, Bad-Belzig Berlin-Stadtbahn BER T1 Wünsdorf-Waldstadt (hourly service)
- RB14: Nauen Berlin-Stadtbahn BER T1 (hourly service)
- RB22: Potsdam Golm BER T1 Königs Wusterhausen (hourly service)
- S9: Spandau Stadtbahn BER T5 BER T1 (every 20 minutes)
- S45: Südkreuz BER T5 BER T1 (every 20 minutes)

#### **Services from 2022 onwards**

Train services will be optimized by the end of 2022. The current Schönefeld railway station will then be re-integrated into the regional transport system. Commissioning of the Dresdner Bahn (Berlin-Dresden railway), due to take place from 2025 onwards, will further expand transport services, reducing the FEX journey time to 20 minutes only.


#### **Road connections**

A separate entry/exit of highway A113 called "Flughafen Berlin Brandenburg" guaranteess direct and quick connections from BER T1-T2 to Berlin city center, while the Berliner Ring road A10 further connects to the broader catchment area.

BER T5 is accessible via no. 7 junction Schönefeld-Süd and the B96a.

Passengers and visitors to BER can choose from more than 10,000 parking lots.






Over the coming years, thousands of new jobs will be created in the airport region over. In 15 years, around 40,000 people may directly earn a living with a job at Berlin Brandenburg Airport. This was the conclusion of a study published in January 2020 by the market research institute Conoscope and the Competency Centre for Services at the University of Leipzig on behalf of Flughafen Berlin Bran- various requirements over the course denburg (FBB). At the moment, more of phases. than 20,000 people are employed as a result of activities at Tegel and Schönefeld Airports. FBB itself has around 2,200 staff.

This is linked with an ever-increasing number of passengers. Passenger volumes for 2040 are predicted to reach around 55 million. A strategic mission statement - the BER 2040 Master Plan - was drawn up in order to provide suitable infrastructure tailored to the forecast passenger volumes by 2040.

The master plan describes further potential steps in airport planning in or-

der to handle the forecast increase in the number of passengers, to continue to drive property development, and to expand media infrastructure. It describes the planned implementation of the infrastructural and urban development mission statement against the background of the sharply rising passenger numbers and puts forward Economics, Infrastructure, and Public suggestions for the gradual expansion of the new BER Airport tailored to the



The development of the BER 2040 Master Plan is based on three leading


- Creation of a centralized and flexible terminal infrastructure by way of additional gates, pier extensions and new satellite constructions with a flexible layout.
- 2. Development of a central plaza at the existing BER railway station and passenger transport system with the aim of absorbing and distributing traffic flows.
- 3. Development of an Airport City, which extends from the terminal to the A113 motorway.


